This product is stable with no know adverse effects in the products intended use as a casting medium.

This product contains 1,2 benzisothiazol-3(2H)-one, Carbamate 3-iodo-2-propynylbutyle and 2-methyl-2H-isothiazole-3-one.

When exposed to water 1,2 benzisothiazol-3(2H)-one, Carbamate 3-iodo-2-propynylbutyle and 2-methyl-2H-isothiazole-3-one may leach from the material.

1,2 benzisothiazol-3(2H)-one, Carbamate 3-iodo-2-propynylbutyle and 2-methyl-2H-isothiazole-3-one are classified as very toxic to aquatic organisms.

**12.2. Persistence and degradability**

Abiotic Degradation Physical- and photo-chemical elimination: The product hydrolyses quickly in the presence of water to: Calcium and Sulfate Ions The individual components are poorly eliminated from water.

Inorganic product which is not eliminable from water through biological cleaning processes.

**12.3. Bioaccumulative potential**

Based on the n-octanol/water partition coefficient significant accumulation in organisms is not expected. No indication to bioaccumulation potential. The ecological data were measured on the hydrolysed product. According to experiences this product is inert and not degradable biologically.

Water-soluble solid. Natural constituent in soils. If product enters soil, it will be mobile and may contaminate groundwater

**12.5. Results of PBT and vPvB assessment**
