Who are we?

Saint-Gobain Formula (hereinafter "Saint-Gobain Formula") is made up of entities of the Saint-Gobain Group ("Group") involved in high-performance gypsum and plasters for specialised industry. Whenever dealing with one of the Saint-Gobain Formula entity (hereinafter "Entity"), **the controller of your personal data will be the Entity** that decides why and how your personal data is processed.

In this notice the terms ("we", "us", "our") refers to the particular Entity that is the controller of your personal data.

- Managing the requests for the exercise of rights where applicable;
- Managing audits, litigations and pre-litigation where applicable;
- Managing the IT systems security.

	<h3>With whom do we share your data?</h3>
<p>When we process your data, we share it with the following categories of recipients:</p> <ul style="list-style-type: none">• Commercial and marketing departments of the Entity which will contact you to respond to your request for information• Commercial and marketing departments of the Entity's affiliates• Audience analysis service• Persons in charge of managing data protection for the Entity.	

	<h3>Is there an international transfer of the data?</h3>
<p>Your data will be transferred or made available to persons located outside the European Economic Area, more specifically in the United States and in China.</p> <p>Safety and confidentiality of these transfers are contractually guaranteed by the application of the standard contractual clauses elaborated by the European Commission.</p>	

	<h2>What are the rights you can exercise?</h2>
<p>The applicable regulations may allow you to exercise the following rights concerning your personal data:</p> <ul style="list-style-type: none">○ <i>Right of access;</i>○ <i>Right to rectification;</i>○ <i>Right to erasure;</i>○ <i>Right to restriction of processing;</i>○ <i>Right to object;</i>○ <i>Right to data portability;</i> <p>There may be situations where we cannot grant your request, but we will of course explain why — for example, if you ask us to delete your data and we are legally obligated to keep a record of that data to comply with law.</p>
